IMPORTANT ENTRY INFORMATION

We are offering a AHA recognized Value show for owners and riders of Arabian, Half-Arabian and Anglo Arabian Horse. You may enter Dressage, Western Dressage or Sport Horse Classes.

We are also offering open to anyone classes in a schooling show format for all non-Arabian horses.

Please make sure you use the proper entry form for either Arabian or Non-Arabian Horses.

You can enter this show online or with a paper entry.

All Dressage and Western dressage classes must be entered by closing date (Aug 23, 2024) since there will be assigned ride times. Dressage classes will tentatively start at 8 am.

The Sport Horse classes in hand and under saddle will be held after the dressage classes are finished (not before 2 pm) and you may enter those on the day of the show.

Ride times will be sent via email (please make sure your email address is legible if using paper entry) and will also be available on the website www.theeleganttrider.com.

SHOW COMMITTEE: The show committee reserves the right to cancel or split classes; limit class size; change arenas; limit the number of rides & number of horses per rider; and cancel or add judges. The show committee also reserves the right to refuse any entries. Every horse entered for competition will comply with the rules of the horse show management, but management will, in no case, be responsible for any loss or damage that may occur, and it shall be condition of entry that each exhibitor shall hold this horse show and the officials and employees of the show blameless for any loss or accident to his horse, employees, equipment, which may occur from sickness, fire or otherwise.

ENTRIES: Accepted on first come, first served basis. Post entries (after closing date) will be accepted on a space available basis. Once the competition is filled a wait list will be established. Proof of memberships and horse registrations must be included with entry. Entry required if schooling only.

RIDE TIMES: Provisional times available at www.theeleganttrider.com and emailed to valid email addresses. Please also check your spam folder. Official times will be posted at the show office by Noon the day before the start of each show. Numbers required all times when horse is outside of stall or not tied to a trailer. Anyone not appearing for any of their dressage tests without prior notification to the show secretary will be "scratched" from their remaining classes. Those rides will be filled if possible.

ARENAS/FOOTING: One sand outdoor warmup arena and one dirt indoor competition arena. Only horses with entries will be permitted in the arenas. Warm up and schooling permitted on Friday before the show between noon and 6 pm. Lunging available in designated areas, but not in the warm-up arena.

CONCESSIONS: Food available on premises.

REFUNDS: All Cancellations must be made in writing either by email, or text. Up through closing date, all fees refunded except office fee. From day after closing to the day prior to competition, class fees will be refunded only if ride(s) can be filled from wait list. During competition days no refunds including for Acts of God. Office fee is never refundable.

SHARPS CONTAINERS: Are located in the show office and barn. Please use them appropriately or fines will be assessed per USEF guidelines. In accordance with the 1989 Federal Waste Tracking Act, which restricts the disposal of medical waste, bio-hazardous medical waste containers will be provided in the stable area. All exhibitors and their agents are responsible for the proper disposal of this waste.

SCHOOLING HORSES: Non-competition, schooling or sale horses will be allowed. An entry for the horse must be submitted and appropriate non-compete and stabling fees paid.

STABLING: Overnight stabling is available on site. **First-come, first-serve!** A \$50 stall cleaning deposit is required upon check-in and will be returned to you once we verify that you have cleaned your stall.

I AGREE as a Horse Show Participant (or Parent/Guardian of Participant if a minor) to waive all claims which may otherwise arise from, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Horse Show (and most other outdoor locations) and can cause infection in humans, as well as in animals.

I AGREE for myself, my heirs, executors, administrators, successors and assigns **to release** AHA, the Competition, the facilities leased by the Competition and the owner(s) of the facilities, and all of their respective officers, officials, directors, employees, agents, personnel, volunteers, affiliated organizations and insurers (collectively, the "Released Parties") from any and **all claims for damage, loss, or injury to myself, other persons, horses or other property belonging to me to the fullest extent** permitted by law that arises out of or relates in any way to the Competition and my participation in the Competition **INCLUDING, BUT NOT LIMITED TO, DAMAGES, LOSS, OR INJURY RESULTING FROM ANY ACTS, FAILURE TO ACT, NEGLIGENCE OR NEGLECT OF OTHER ENTRANTS, THE RELEASED PARTIES, THEIR CONTRACTORS OR INVITEES**, as well as for theft, vandalism, fire, other casualty damage, or damage arising out of any defects in the premises.

Should a hearing be requested, **I agree to accept AS FINAL** the decision of the particular hearing body. **I agree to release, hold harmless and not to sue** AHA, the Competition Sponsor, their officers, directors, employees, volunteers or members concerning any decision of AHA, the Competition, its Show Commission, Show Officials or any hearing body that relates to my qualifications or my horse(s)' qualifications to enter the Competition or any results of the Competition.

I AGREE that AHA has the sole right to control, sell, supervise or give away (or assign to others the right to do so) the exclusive rights to broadcast, televise, reproduce, transmit and disseminate all or part of this event, and I agree that AHA may use or assign, in any way AHA sees fit, photographs, films, videos, audios, cablecasts, or other likenesses of me and my horse taken during the course of the Competition for the promotion, coverage or benefit of the Competition or AHA. Those likenesses shall not be used to advertise a product and they may not be used in such a way which implies endorsement of any company, product, product category or service. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

I AGREE and represent that I am qualified and eligible to enter and/or participate in the Competition and every horse I am entering is qualified and eligible as entered .

I FUTHER AGREE that by participating in an Amateur class that I am in compliance with the USEF Amateur rule.

By signing below as a parent or guardian of a junior exhibitor, I consent to the child's participation and agree to all of the above provisions, and further agree to assume all of the obligations of this AHA Assumption of Risk, Release and Indemnification personally and on behalf of the child.

This AHA Assumption of Risk, Release and Indemnification is governed by the Laws of the State of Colorado and is intended to be interpreted as broadly as possible. I agree that exclusive jurisdiction and venue (place) for any legal action against AHA, its officers, directors, employees, volunteers or agents shall be in the local district courts or the federal court of the State of Colorado. If any part of this agreement is determined to be unenforceable, all other parts shall remain in effect.

The parties agree that this agreement may be electronically signed. The parties agree that the electronic signatures appearing on this agreement are the same as handwritten signatures for the purposes of validity, enforceability, and admissibility.
